



# ARTICLES OF INCORPORATION

The undersigned incorporator or incorporators, desiring to form a corporation (hereinafter reserved to as the "Corporation") pursuant to the provisions of the Indiana Not-For-Profit Corporation Act of 197 (hereinafter referred to as the "Act"), execute the following Articles of Incorporation:

#### ARTICLE I Name

The purposes of this corporation are to promote a greater awareness of Indian culture, to organize and conduct cultural programs based on Indian traditions, to support humanitarian causes, to promote inter-religous and inter-cultural understanding amongst all peoples, to foster Indo-American goodwill and understanding through educational and cultural extensions, and to cooperate with other similar organizations in programs and activities of mutual interest.

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, or such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

No part of the net earnings of the corporation shall in re to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporat on shall be authorized and empowered to pay reasonable compensat on for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third here f. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not particip; te in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities permitted to be carried on (a) by a corporation exempt from federal, income tax under section 501(c)(3); of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under sect on 170(c)(2) of the Internal Revenue Code of 1954.
